- Your resume
- Your undergraduate transcript
- Your first-semester law school grades (if first-semester grades are not available prior to the application deadline, please submit your first-semester course list and forward a copy of your transcript when it becomes available)
- Two to three references, one of whom must be a law school professor
- A legal writing sample

Applications will be accepted between December 1, 2008 and January 22, 2009. All applications will be reviewed on a rolling basis. Recipients will be selected by February 27, 2009. Please send your materials to the office for which you wish to be considered.
