


## WHO ARE WE?

### A TYPICAL DAY

Seat at time of writing: Corporate

**8:00am:** We are in a busy period coming up to signing a transaction. I therefore start my day by quickly checking my emails before I make my way to the office, in case I need to attend to anything urgent that has come in overnight. If nothing requires immediate attention, I quickly flag the tasks that I need to perform once I am in the office.

**9:30am:** I arrive at the office and have a quick catch up with my supervisor, during which we discuss which tasks should be prioritised. I then begin my first task of the day: drafting board minutes, which I aim to circulate to my supervisor before lunch.

**11:00am:** Time for a matcha! I check with my fellow trainees and other colleagues to see who wants to come to the nearest cafe.

**1:30pm:** I circulate the draft board minutes to my supervisor before going for a walk and grabbing lunch with a colleague. Then I return to my desk.


**2:30pm:** I am back at my desk and start my second main task for the day, which is to update a due diligence report following a call with the client yesterday evening. Alongside this, I liaise with the litigation team to confirm the status of litigation searches for the target company so that I can add these to the report.

**4:00pm:** Time for a tea break! I meet with some of the other trainees in the kitchen for a quick break.

**4:15pm:** I head back to my desk after receiving a notification of an email on my work phone with a short last-minute research point. The query related to the sale of shares in an AIM listed company.

**5:00pm:** I finish my research and pull together a short note summarising the position, including the key statutory provisions and case law, before sending it to my supervisor. I stay around for a few minutes in case any follow up questions arise, and check if there's anything else I can help with today. After my supervisor confirms that there is nothing else to be done this evening, I update my to do list for the next day and log off.





#### **OUR TRAINING CONTRACT**

Dorsey takes on two trainee solicitors every September. We look for trainees who can really add value to our team, which goes beyond billable hours. **1 May 2026** Application window opens.

**30 June 2026** Deadline for training contract applications.

Applications for September 2027 training contracts will be accepted between 1 May 2026 and 30 June 2026. Please send a covering letter and CV to Joseph Lewin (<a href="mailto:lewin.joseph@dorsey.com">lewin.joseph@dorsey.com</a>), the Training Principal.

Covering letters should set out why you are interested in a career as a solicitor and why you are interested in pursuing that career at Dorsey in particular. We would also be interested in examples of your non-academic achievements or activities. Please keep covering letters to no more than one page.

Applicants must be ready to begin in September 2027, either undertaking or having completed a final year in law or a diploma in law, and able to work as a trainee solicitor in London without sponsorship.

July / August 2026 First round interviews.

Second round interviews in person, including a written assessment and presentation.
