## Award

We are pleased to announce the 2023 Dorsey & Whitney Diversity Fellowship program. This is the eighteenth year that Dorsey has offered the Diversity Fellowship.

Dorsey's Minneapolis, Salt Lake City, and Seattle offices will select a first-year law student to receive the Dorsey Diversity Fellowship and work as a 2023 summer associate. Recipients will receive \$10,000 toward law school tuition and expenses for the 2023-2024 school year. Recipients who return to Dorsey for the summer following their second year of law school will receive an additional \$10,000 for the 2024-2025 school year, and an additional \$10,000 if they join the firm as an associate.

## Eligibility

All law students from underrepresented communities who attend an ABA-accredited school are eligible to apply, subject to the class year requirement as noted above. Successful applicants will have a demonstrated record of academic achievement and a commitment to promoting diversity in the legal community.

## Application

To apply, please submit the following materials to be considered:

- Your resume
- A cover letter that includes a personal statement addressing what diversity means to you and why you are interested in Dorsey
- Writing Sample
- An unofficial undergraduate transcript
- An unofficial law school transcript\*

*\* If your law school grades are not available when you apply, please submit your first semester course list along with all other application materials and indicate in your cover letter when we can expect to receive your transcript. When grades become available, email your unofficial transcript to [recruiting@dorsey.com](mailto:recruiting@dorsey.com).*
